If the customs documents are prepared properly, dogs/cats can be released within 24 hours.</li> <li>As it normally takes about 5-6 hours from arrival at AOE Incheon to delivery residence in Seoul, please arrange the airplane which lands at AOE in the morning time during weekdays.</li> <li>Birds: 5 days of quarantine.</li> </ul> |
